MICROSOFT'S MOTION TO SEAL

1 This matter came before the Court on the motion of Plaintiff Microsoft Corporation to allow
2 the filing under seal of documents filed by Microsoft. Upon consideration of the Motion to Seal, the
3 pleadings and motions filed herein, and the arguments of counsel, it is hereby ORDERED that the
4 instant case and the following documents be filed and maintained UNDER SEAL in accordance with
5 Fed. R. Civ. P. 26(c)(1) and Local Rule 10-5 until after Microsoft is able to execute the TRO:

3 necessary, including to commence its efforts to provide Defendants notice of the preliminary
4 injunction hearing and service of the Complaint.
